AWARDS BACKGROUND 奖项背景

The BDO ESG Awards recognises outstanding listed companies in Hong Kong that have made a positive impact in the areas of Environmental, Social and Governance (ESG) – those that implement outstanding sustainability initiatives.

BDO, the world's fifth largest accountancy and advisory network, inaugurated the BDO ESG Awards back in 2018, becoming a pioneer in advocating companies' acceptance of their social responsibilities through the integration of sustainable practices into their business models. With 2023 marking the 5th anniversary of the Awards, it has again sought to be both an important motivator of positive change and a symbol of excellence bestowed on companies that have excelled in the areas of ESG.

The BDO ESG Awards has adopted 'Carbon Neutrality' as the theme of this year in recognition of the urgent need to combat climate change. This year's Theme Award will put a spotlight on the industry best practice to recognise listed companies' effort in achieving carbon neutrality and with excellent performance in the following aspects: (1) biggest reduction in carbon emission (absolute and intensity) from business for the year; (2) carbon reduction initiatives launched during the year that could significantly reduce carbon emission from business in the long-run; and (3) long-term vision and action plans implemented.

The Awards that will be presented this year are Best in ESG Awards, Best in Reporting Awards, ESG Report of the Year Awards, Theme Award as well as the newly launched Outstanding ESG Performance of H-share Companies Awards.

BDO环境、社会及管治大奖为表扬于环境、社会及管治（ESG）范畴上表现突出并有积极影响的香港上市公司而设。

全球第五大会计及咨询网络BDO自2018年起举办BDO环境、社会及管治大奖，鼓励企业将可持续发展纳入业务模式，借以承担社会责任，为可持续发展的倡导者。2023年迎来大奖成立五周年，BDO将一如既往推动企业在ESG方面的发展，而大奖亦标志着企业在ESG各个领域表现超卓的象征。

BDO环境、社会及管治大奖本届的主题为「碳中和」，除配合大奖提倡卓越ESG发展的宗旨外，亦带出应对气候变化的迫切需要。今年的「主题大奖」将表扬致力实现碳中和、并在以下三个主要方面表现优秀的上市公司，包括(1) 年度最大的碳排放减幅（绝对值与强度）；(2) 本年度推出的减排措施能够长远显著减少商业活动的碳排放；(3) 订立的长期愿景及实际计划。

本届大奖所颁发的奖项组别包括「ESG最佳表现大奖」、「最佳ESG报告大奖」、「ESG年度大奖」、「主题大奖」及新增的「ESG突出表现大奖 – H股公司」奖项。

AWARDS CATEGORIES AND JUDGING CRITERIA 奖项类别及评审标准

Entries from non-H-share companies are placed into two award categories - 'Best in ESG' and 'Best in Reporting'. The top three companies from each of the large market capitalisation, middle market capitalisation and small market capitalisation will be selected as winners of each of the award categories.

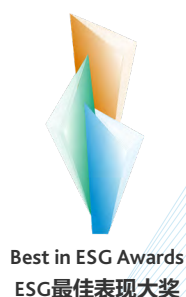
Companies that performed best in 'Best in ESG' and 'Best in Reporting' categories will be awarded the 'ESG Report of the Year'.

SYMPOSIUM: SHAPING BUSINESS STRATEGIES FOR CARBON NEUTRALITY

座谈会：打造碳中和之商业策略

Climate change is one of the most pressing challenges facing the world today. The past summer, individuals in China, Europe, the United States and even Hong Kong felt record-breaking heat waves, posing health risks and threatening crops and wildlife. According to the World Weather Attribution Network, the heatwaves were linked to human-caused greenhouse gas emissions making the heat wave hotter than it would otherwise have been.

Climate change is not just an environmental problem, it is an economic one. Rising temperatures threaten growth and macroeconomic stability, pushing sustainability to the top of the agenda. Investors are demanding a detailed environmental, social, and governance (ESG) plan and path for net-zero carbon emissions. Meanwhile, businesses are grappling with how to mitigate adverse environmental impacts while making a profit. The Hong Kong Stock Exchange has recently proposed one of the strictest ESG requirements with climate-related disclosure requirements.

Adding to these challenges, ESG consultants commented there is little agreement on what ESG includes, how to apply the proposed requirements and how best to capture required data. How can businesses meet the needs of investors and stakeholders, align to science-based targets, accelerate the transition to low-carbon and make ESG a game changer?

气候变化是当今世界面临最紧迫的挑战之一。去年夏天，中国、欧洲、美国甚至香港都能感受到了破纪录的热浪，带来了健康风险，并威胁农作物和野生动物。根据世界气候归因组织，热浪与人为温室气体排放有关，导致热浪比以往更热。

气候变化不仅只是环境问题，也是经济问题。气温上升对经济增长和宏观经济稳定造成威胁，导致可持续发展成为最重要的议程。投资者要求制定详尽的ESG计划及实现净零碳排放的路径蓝图。与此同时，企业在赚取盈利的同时，亦努力减轻对环境不利的影​​响。香港交易所最近推出一项更严格的ESG守则要求，其中包括气候相关的披露要求。

除了这些挑战之外，ESG顾问还表示，对于ESG所包含的内容，如何应用拟议的守则要求，以及如何最好地获取所需数据，各方几乎没有达成一致。企业如何满足投资者和持份者的要求，与基于科学的目标保持一致，加速向低碳转型，并且ESG成为游戏规则的改变者？

Christine Loh is the Chief Development Strategist at the Institute for the Environment, Hong Kong University of Science and Technology, Scholar in Residence at Asia Society Hong Kong, and Visiting Scholar at Anderson School of Management's Center for Global Management, UCLA. Loh was the Undersecretary for the Environment in the HKSAR Government (2012-17). Between April 2019 and March 2020, she was the Special Consultant to the Office of the Chief Executive of the HKSAR Government on the mainland's ecological civilization policy. She has a long history in public policy and politics, having been a legislator, and then was the CEO of a non-profit public policy think tank. She has a wide and unusual range of expertise that spans the environment, energy, development, and geopolitics. She is a published author of many academic and popular works. Her latest book, published by Hong Kong University Press in 2023, is about COVID-19 and its global socio-economic and policy implications. Loh is a Director and Trustee of CDP Worldwide, and Director of the Global Maritime Forum, New Forests Pty Ltd, and Towngas Smart Energy Company Limited. She is a lawyer by training, and a commodities trader by profession.

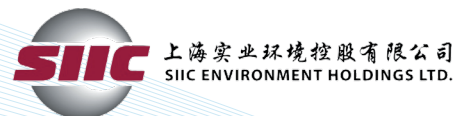

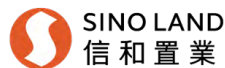
